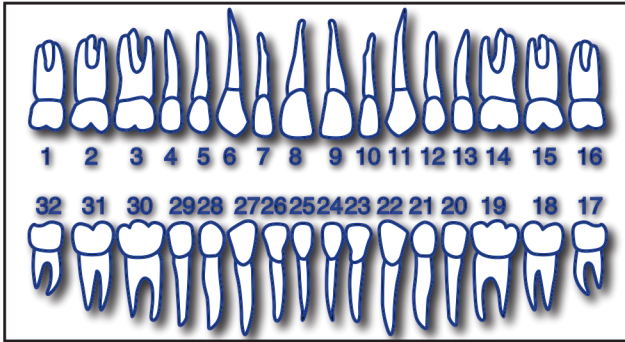

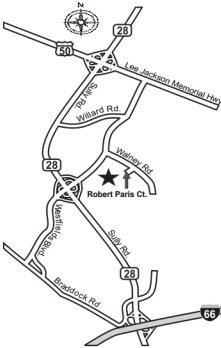

**From the Dulles Toll Road (VA-267) and Rte. 28:**

Merge onto VA-28 South- Sully Road via Exit 9A towards Centreville/Manassas. Proceed 7 miles to Westfields Blvd East. Follow Westfields Blvd. approximately ½ mile and turn right onto Walney Road. The office will be on your immediate right.

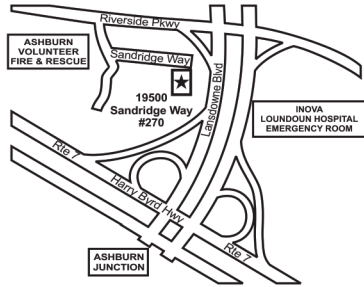
**From Rte 50:**

Go south on Waney Road to the second light. This is the intersection of Waney Road and Westfields Blvd. Proceed left and the office is immediately on the right side.

**From Interstate 66:**

Proceed west towards Manassas/Front Royal. Merge onto VA-28 North/Sully Road via Exit 53B. Take the Westfields Blvd East exit. Follow Westfields Blvd approximately ½ mile and turn right onto Walney Road. The office will be on your immediate right.

Exit onto VA-2400 North/VA-901 towards Lansdowne Blvd.

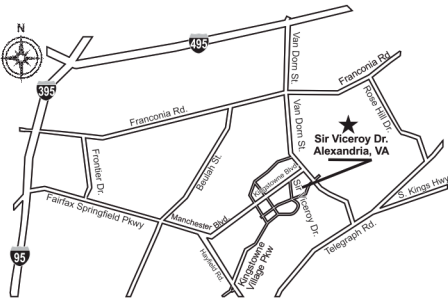
Continue to follow 2400 North.

Exit 173 toward VA-613 Van Dorn St./Franconia.

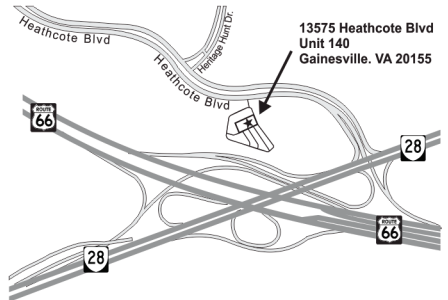
Turn right onto south Van Dorn St.
